**PET CONTACT APPLICATION FORM**

**This Register is a contact service only.**

**Club members using the pet contact service agree to abide by the following conditions:**

1. The Register is only available to members of more than 12 months standing.
2. Older bitches over the age of 6 months must be desexed and a copy of the sterilisation certificate attached.
3. No member will list pets on the Register on behalf of non members.
4. Puppies will be placed on the Register for one month, the member agrees to contact the Register Officers weekly and to inform them when all puppies are sold.
5. All puppies placed on the register to be sold with Dogs NSW Limit register papers only.
6. All puppies must be microchipped as required by State law.

**Members MUST comply with the Dogs NSW Regulations relating to the care and sale of dogs as listed below:**

**PART XIII - Dogs NSW Code of Ethics:**

8. A Member shall provide to all purchasers of dogs sold or placed by the Member, written details of all dietary and immunisation requirements and/or appropriate publications relating to such requirements and responsible dog ownership.
11. A member shall ensure that when selling or transferring a dog to another person, that documents, as required by the Regulations, are provided to the purchaser of the dog.
13. No dog should be sold in a state of ill health.

**PART XIV – Guidelines for the care and management of keeping and breeding dogs.**

2. Responsibilities of owner
  - 2.1.7. Maintenance of hygiene of the premises and health of dogs held.
6. Health care
  - 6.1.2 Programs for treatment of gastrointestinal worms must be in place and in accordance with veterinary advice.
10. Sale of animals
  - 10.1 No puppy may be sold before it is 8 weeks of age.
  - 10.2 No dog may be sold unless it has been vaccinated against distemper, hepatitis and parvovirus and is accompanied by a current vaccination certificate.
  - 10.3 The purchaser of any puppy or dog should be handed at the time of sale printed advice about the animal including information on:
    - 10.3.1 general care, housing and management requirements
    - 10.3.2 appropriate diet;
    - 10.3.3 responsibilities of pet ownership
    - 10.3.4 vaccination, desexing and registration where appropriate.
